



# NICTD West Lake Corridor Project Construction Update

## Week of 2.12.2024 & 2.19.2024

<u>Hammond</u>

- Closures
  - o Russel Street (between Hohman Avenue and Lyman Avenue)
    - Russel Street is closed at West Lake Corridor
    - Follow posted detour.
  - o State Street
    - Closure is currently active.
    - Willow Court is open.
- Utility Relocation, Sewer & Water
  - Utility Installation
    - Future Hammond Gateway Station
      - **O** No impact to vehicular traffic

#### Monon Trail Closure

- o Monon closed from 173<sup>rd</sup> Street to Little Calumet River
  - Closed indefinitely until rail operation has been completed/pedestrian bridge is installed.
  - No connection to Lackawanna Trail.
- Rail Construction
  - Track work ongoing from Little Calumet River to 173<sup>rd</sup> Street.
    - No impact to vehicular. Equipment will cross intersections with roadway flagger.
  - Track work from Future Hammond Station to Sheffield Ave
    - Contractor working near Sheffield with no vehicular impact.
- Hanover Street will be permanently closed between Wabash and Sheffield Avenues.
- Dearborn at Gostlin Street will be closed permanently.
  - No impact to vehicular traffic.
- Substructure Work for Bridges, Elevated Structures, and Retaining Walls
  - Bridge over IHB Railroad (Between State Street and Willow Court)
    - Setting bridge structure Mid-January.
      - O No impact to vehicular traffic.
    - Bridge over CSX Railroad (near Sheffield & Hanover)
      - Install waterproofing on bridge deck.
        - O No impact to vehicular traffic.

### <u>Munster</u>

- Closures
  - o Manor Avenue (Between Ridge Road and Broadmoor Avenue) Closure Active
    - See attached detour.
  - o 45<sup>th</sup> Street Lane Closures as needed from dates 2/15/24 3/1/24
    - Single Lane closure on the furthest North Lane or the furthest South Lane.
      - Follow posted signage.
      - Lane closure details attached.
- Retaining Wall between 45<sup>th</sup> Street and Superior Ave
  - o Set and backfill of precast retaining wall.
  - o Trucking operations through the Town of Munster, minimal impacts to vehicular traffic.
- Retaining Wall/Structure between Fisher Street and 45<sup>th</sup> Street
  - o Retaining Wall work continues.
- Elevated Structure Work at 45<sup>th</sup> Street
  - Construction Entrances on the North and South sides of 45<sup>th</sup> Street for deliveries and flagging of equipment moves. Construction Entrance signage is displayed.
    - Trucking operations through the Town of Munster, minimal impacts to vehicular traffic.
- Monon Trail will be closed for the foreseeable future from Little Calumet River to Fisher
  Street
  - Closure will last until rail operation is complete from Fisher-Ridge & Ridge to Little Calumet. Tunnel at Belden Place is now open. Access from Manor Avenue or Freddrick Avenue. Monon Trail remains closed in this area due to Bridge construction at the Little Calumet River.
- Structure work at the Little Calumet River.
  - o Bridge Erection and Site Grading ongoing.
- Station Work
  - o Munster-Ridge station
    - Electrical work ongoing.
    - Landscaping work ongoing.
  - o Munster-Dyer East Platform Access
    - Station excavation ongoing
      - Trucking operations on Allison Road, minimal impacts to vehicular traffic.
- Munster-Dyer East Parking Lot
